Pool and Tennis Reminders

We want all our neighbors to be able to enjoy our facilities to their fullest. In order to do this, however, we must all obey the rules. Please ensure you and your family read the posted rules, and let's all help protect our common area from misuse. A few rules in particular that need reminding:

- No pets inside the fenced pool area
- You must be at least 12 years of age to swim without a guardian when a

- lifeguard IS on duty
- You must be at least 16 years of age to swim without a guardian when a lifeguard IS NOT on duty.
- Without a lifeguard on duty, swimming solo is prohibited at all ages. There must be at least 2 people at the pool if no lifeguard
- Clean up after yourself
- Protect our equipment (chairs, umbrellas, no bikes/scooters on the tennis courts)

Help Keep Forest Brook Safe!

Lastly, please continue to keep safety first during the summer months when kids are out of school. Please drive the speed limit, be on the lookout, and practice good firework safety during the July 4th holiday!
